Payment of \$3,000 Due by January 15, 2021

Payment of \$8,000 broken down into 8 equal payments of \$1,000 due by March 1, April 1, May 1, June 1, July 1, August 1, September 1 and October 1

When you mail your payment, please put "CT Unit (Your Condo Number)" in the Memo Field on your check or electronic check. If you prefer, the attached PDF can be submitted along with your payment to document your Unit Number. These Coupons will also be available on the Crystal Tower Condo Association page.
