Roof Lawsuit Update

The lawsuit against Willoughby Roofing continues through the lengthy legal process. At the next hearing on October 27th, our attorney will demand we proceed to mediation without further delay or go to trial. As a reminder, we are seeking damages for the removal cost of the roof they installed, the amount we paid them for the roof, and the damage to units caused by the roof leaking. This could be approximately \$250,000 - \$275,000, and the Board will keep the owners informed as the case moves forward.
